Operation Doublet	Greater Manchester Police	Following the following the 2011 investigation into child sexual exploitation in Rochdale, GMP identified a number of cases, which broadly took place between 2004 and 2008, across Greater Manchester where teenage girls were being sexually exploited by older men. On 4 February ten men were found guilty of a range of serious sexual offences during two trials. The convictions relate to offences committed against eight victims who were aged between 13 and 23 at the time of the abuse. All men bar one who remains wanted, have been remanded to appear for sentencing on the Thursday 7 and Friday 8 April 2016.	Operation ongoing. On 24 February, three men and two women were found guilty of multiple child sexual exploitation offences against 15 young girls in Rotherham between 1987 and 2003. AT the beginning of the trial an additional man pled guilty to multiple offences. Two men were acquitted of all charges. Sentencing will take place on Friday 26 February.

OPERATION PALLIAL	NCA	A trial at Mold Crown Court under Operation Pallial, led by the NCA. A former professional wrestler was at the heart of a "predatory" paedophile ring that abused young boys at sex parties in the 70s and 80s. Mold Crown Court heard victims were passed around a group of men at the Wrexham home of Gary Cooke. Mr Cooke and six co-defendants, are on trial and deny a range of sex offences against boys aged 10 to 15. The court heard the boys were groomed by being offered treats such as cinema trips and given attention, which all led to "grave sexual abuse". One of the defendants who visited Mr Cooke's addresses was teacher and care home owner Roger Griffiths, a convicted paedophile, the court was told. The case has been bought as part of Operation Pallial, the National Crime Agency's investigation into historical child abuse. The trial finished on 2 July. Sentencing will take place on 25 September. Five men have been found guilty of a total of 34 sexual offences, following a National Crime Agency investigation in to past child sexual exploitation and abuse in the care system in North Wales. The five victims in this case were aged between 10 and 15 years of age and were abused by a predatory ring of paedophiles who operated in the Wrexham area during the 1970s and 1980s. George Neil Phoenix, a former bus driver from Wrexham, was found guilty of one count of sexual abuse, jailed for three-and-a-half years	A further trial began on Monday 11 January of two men. The charges relate to child cruelty and assault at the Bryn Alyn Hall – privately owned care homes in North Wales. The case will be sworn in at Mold on Monday, then transferred to Chester Crown to continue from Tuesday.

OPERATION HYDRANT	NCA	Operation Hydrant is coordinating multiple historical child sexual abuse investigations around the country. Relevant investigations are those which involve either people of public prominence and/or abuse which has taken place in an institution. In most cases the victims are reporting abuse which took place when they were children.	The investigation continues. On 15 June 2015, it was reported that Guernsey Police were investigating an allegation of historic child abuse involving prominent people in the community as part of Operation Hydrant . Police confirmed that the case remained in its infancy and that given that it is a complex and sensitive investigation, and that no further details will be released at this time.
OPERATION YEWTREE	MPS	Operation Yewtree, the enquiry into child sexual exploitation by Jimmy Savile and others is led by the Metropolitan Police Service (MPS) Child Abuse Investigation Command on behalf of all forces. It commenced on the 5 th October 2012 in response to the broadcast of ITV's Exposure programme on the 4 th October. It was setup as a three strand investigation into historic allegations of sexual abuse against Jimmy Savile; Savile and others; and others. It moved from an assessment to a formal criminal investigation in mid October 2012 and the investigation remains ongoing.	On 30 June 2014, Rolf Harris was found guilty of 12 counts of indecently assaulting four girls in the 1960s, 1970s and 1980s. On 4 July, he was sentenced to a total of 5 years and 9 months imprisonment. On 30 June, the Attorney General decided not to refer RH's sentence to the Court of Appeal despite 150 complaints over its "leniency". On the 1 August the Judicial Office has stated that RH has applied for permission to appeal against his conviction for indecent assaults. On 31 October, he lost the first round of a legal challenge against his conviction for indecent assaults. He is still able to renew the application at the Court of Appeal.
			Former BBC Radio 1 DJ Chris Denning was tried for alleged sexual offences, all dating from 1967 to 1985, and are related to 22 boys aged nine to 16. Denning was remanded in custody. He appeared at Southwark Crown Court on 5 August and pleaded guilty to 29 charges of indecent assault, indecency with a child and more serious sexual offences, whilst denying 12 other charges. He since pleaded guilty to all remaining charges. On 16 December, Denning was sentenced at Southwark Crown Court to 13 years imprisonment.
			On 27 February, Gary Glitter was sentenced to 16 years at Southwark CC for attempted rape, four counts of indecent assault and one of having sex with a girl under 13. An later appeal against these convictions was thrown out by three judges.
			On 13 May 2015, a 69-year-old man was arrested by MPS detectives from Operation Yewtree , the inquiry set up in the wake of the Jimmy Savile scandal. The man, from Milton Keynes, was arrested on suspicion of sexual offences. Two men will appear before Mold Magistrates on October 9 2014, after being jointly charged with child cruelty offences against a boy. In addition, another man will appear before Mold Magistrates on October 16 2014, charged with two offences of indecent assault against a boy. A total of 21 people have now been arrested or interviewed under caution by NCA Officers. Of these a total of 11 people have been charged, with the remainder on bail pending further enquiries. Operation Pallial has been contacted by 316 people. There are currently 161 active complaints being investigated. The date range of offences under investigation starts in 1953 and ends in 1995. The victim age range is from six years old to 19 years old, with the majority of victims being boys. Watkins was jailed after admitting a catalogue of serious sex offences involving children. He admitted the attempted rape and sexual assault of a child under 13 but pleaded not guilty to rape. He was arrested on 16 December on suspicion of trafficking for the purposes of child sexual exploitation. Police have released him on bail for a second time until a date to be confirmed. Latest information has been commissioned from Thames Valley Police.
GMP	This case involved the arrests of 11 men in south Manchester as part of a crackdown on child sexual exploitation (CSE). The suspected abusers, aged between 19 and 38, were detained for alleged offences including sexual activity with a child, attempted indecent assault, inciting a child into prostitution, abduction and rape. The arrests were made under Operation Heliodor , which is part of Project Phoenix, a multi-agency campaign tackling CSE in the Greater Manchester area. The investigation continues.
Northumbria Police	Operation Sanctuary is the overarching name of Northumbria's investigation into CSE. The investigation began in January 2014, and has since been broken down
